In addition to passing the online exam every year and viewing the annual rules presentation, each referee assigned to NCAA wrestling competition is required to attend an in-person clinic a minimum of once every three years. An institution using a nonregistered referee shall be subject to any or all of the following penalties: monetary fine (\$50 up to a \$300 maximum penalty); disqualification of head coach for one or more competitions; and private or public reprimand.
